The purpose of the study is to examine the effectiveness of treating children, with recurring illnesses, with apiary products that are manufactured in an "artificial field" technology, and have controlled attributes (manufactured by the Zuf Globus Ltd. Israel labs Company).

56 children, aged 2 to 16 with no sensitivity to anamnesis, were tested. They were treated with apiary products dosed according to the age of the child; from 0.25 teaspoon to one teaspoon three times a day, during two months.

Conclusions concerning the effectiveness of the treatment were based on comparison of illnesses frequency among the children, before and after treatment.

Study results:

32 children received both BronchoMel and Forcemel and among 80% of those tested, a decrease of 30% in recurring visits to the physician were recorded, indicating a weighted improvement of 66% in their condition.

24 children received GronMel and among 70% of those tested, a decrease of 30% in recurring visits to the physician were recorded, indicating a weighted improvement of 58.6% in their condition.

During treatment, no side affects related to the apiary products appeared.

Conclusions:

- The products are safe for use with children of age two and up.
- The products are effective in treating recurring infections in the upper respiratory system, pneumonia and sore throat among children.
- Treatment with apiary products significantly reduces the need for medicinal treatment among children.
